The organization stepped in to help after hearing that Joanne's 14-year-old grandson had recently moved in with her, and was sleeping on a used mattress because there was no extra bed in Joanne's home and no funds to purchase one. Joanne was provided with not one, but two, brand new twin bed frames, along with mattresses, bedding and a matching dresser. Joanne's grandson is also enjoying a new laptop computer, courtesy of St. Andrew's. "It was overwhelming and such a blessing to receive so many wonderful gifts," said Joanne. "I've never seen my grandson smile so much. These surprises really lifted his spirits and I can't thank St. Andrew's enough."
